FC06/15 BAD APPLES CELEBRATION OF YOUTH

The Committee considered a request from Bad Apples towards events to provide free dance and activities to engage young people through workshops with well-known street dancing crews. The events would focus on the Sports Centre during a school holiday period to promote team work, respect and physical fitness.

Members welcomed the intention and support opportunities and were keen to see maximum engagement of local teenage young people in particular and felt that a detailed scheme should be put together for a suitable date next year that would allow wide-scale promotion and take up.

FC07/15 YOUTH DEVELOPMENT TUTORS

A request had been received from the Trustees of Newbiggin by the Sea Partnership Limited to assist with gap funding to ensure the retention of the Youth Development Tutors engaged in a range of musical tuition for local young people. In the event that the current main grant funding was not resolved until December a small shortfall could arise in the project.

There was considerable discussion of the issues of the importance of support for young children and of repeat funding to the same organizations as well as the use of grants or loans. Assistance was agreed in principle although as it was not quantified Members requested further information.
