GC04/16 APPLICATIONS FOR GRANT

A range of applications for grant assistance from local group applicants were considered in turn by the Committee.

Contributions were sought towards the work of voluntary groups supporting disabled people; community performances in the Centenary year of the Male Voice Choir; fundraising activities at RNLI Harbour Day by the Ladies Team; fundraising support for the community including PA system for use at funerals. The Traders Association sought support for the visitor attraction events for both the May and August Bank Holidays while the Scouts wanted to raise the profile and encourage recruitment. . .

Members considered the detail of the applications and some additional information provided to confirm local community benefit. All applications were supported in principle but Members felt that matters relating to August Bank Holiday and the Tall Ships related events should be referred to the Council for consideration for funding from a separate budget.
