It was confirmed that arrangements for parking of traders' vehicles throughout the trading period were agreed by the garage at the rear of the Dolphin former public house.

Councillor Rogers and the Town Clerk would supervise the market operations on 14 August.

RESOLVED that the arrangements be confirmed.

MC12/10 ADVERTISING

Arrangements had been made to place an advertisement in the News Post Leader and for a feature article with hopefully other local traders' adverts alongside. The relative costs were considered.

Banner advertising was considered by the members to be necessary and information had been obtained by Councillor Peden to show that three banners of varying sizes could be obtained within the available budget. Locations considered were the roundabout at North Seaton; White House Corner and the Quay Wall.

- (2) The Town Clerk be authorised to acquire three plasticised advertising banners from Needprint within a budget of £250.
