## C052/14 MINUTES OF THE LAST MEETING

The minutes of the meeting held on 12 November 2014 were agreed as a correct record and signed by the Mayor.

## C053/14 MINUTES OF THE GRANT COMMITTEE

The minutes of the Grant Committee held on 08 December 2014 were received for information the Committee having acted under delegated powers.

#### C054/14 MINUTES OF THE FINANCE COMMITTEE

The minutes of the Finance Committee held on 15 December 2014 had been circulated and agreed although the budget recommendations would be considered later in the meeting.

Resolved that: The minutes of the meeting held on 15 December 2014 be approved with the budget recommendations to be considered later on the agenda.

## C055/14 DECLARATION OF MEMBERS INTERESTS

# C056/14 Dispensation for Members to set the Precept

The Town Clerk reminded Members of the change in legislation that had omitted the previous dispensation for Members in relation to setting the local Council Tax and Precept applying to properties for which interests had been declared in the statutory register and invited the Town Council to grant dispensations.

RESOLVED that: all Members of the Town Council are granted a dispensation to take part in the setting of the Precept.

# C057/14 Property Tax Base for setting the Precept

The County Council had advised that the base figure for 2015 – 16 was 1,369 after adjustment for those properties that were exempt discounted or in receipt of Council Tax Benefit. This Property Tax Base was a small increase on the current year and would be used to calculate the proportion of Precept to be recovered from each other property in the town.

**RESOLVED** that: the Property Tax Base figure of 1,369 is noted.

# C058/14 Budget for 2015 - 16

The recommendations from the Finance Committee as set out in Appendix 1 were referred to which incorporated existing budgets for local services and administration of the Council.

The Town Clerk referred to the positive feedback from local people and visitors regarding improvements to the town and bay following the environmental improvement schemes and enhanced services partnership with the County Council. Members supported similar arrangements for the following year and some additional funding was required to maintain and replace assets around the town and in conjunction with contributions from Portas Team for the Atlee play area and Christmas lighting.

RESOLVED that: the Town Council Budget for 2015-16 as set out in Appendix 1 be agreed at a total sum of £188,795.

# C059/14 Precept for 2015 - 16

Following the recommendation from the Finance Committee to allocate £10,000 from balances towards the budget previously agreed and the property tax base the Precept request would amount to £178,795.

RESOLVED that: the Precept for 2015 – 16 be £178,795.
